Our core work since 1995 has been in researching the distribution, abundance and population trends for whales, dolphins and seabirds from commercial vessels in the Channel, Bay of Biscay, North Sea, Irish Sea and beyond.

We also believe strongly that engaging local communities to reinforce their passion about wildlife is a key success factor in marine conservation and as such local boat operators and the public play a vital part in our coastal projects.

Public awareness of marine wildlife is a vital part of MARINELife's role and to date over 1 million people have been part of our education work which is striving to foster a new appreciation for the marine environment.

Key research projects for MARINELife include:

- ◆ Studying White-Beaked Dolphin and Bottlenose Dolphin population dynamics through targeted and opportunistic surveys and photo-identification
- ◆ Partnering with commercial vessel operators and other like-minded organisations and universities to generate meaningful scientific data for use by policy-makers
- ◆ Researching critically endangered Balearic Shearwaters in the Channel to understand the factors explaining their presence during the summer months
